#### Specialty Retailer of Electronic Nicotine Delivery Systems Permit Third-Party Scanning Software Approval Request

This approval request form is intended only for Specialty Retailer of Electronic Nicotine Delivery Systems Permit Applicants to request approval of the third-party scanning software to be utilized within the permitted establishment.

Pursuant to Act 2025-403, all applicants for a Specialty Retailer of Electronic Nicotine Delivery Systems (ENDS) permit must submit detailed information regarding the operation of the third-party scanning software to be utilized for approval by the Alabama Alcoholic Beverage Control Board. Along with this information, please submit this completed and signed form to [nicotine@abc.alabama.gov](mailto:nicotine@abc.alabama.gov). Signatures may be completed electronically. Allow up to two weeks for processing. If your third-party scanning software is approved, you will receive a stamped, approved copy of this document. The approved copy must be included with your application for a Specialty Retailer of ENDS permit (LCD-1) as part of the required documents. As this is a new requirement of Act 2025-403, existing Specialty Retailers of ENDS Permit holders must comply with this law immediately and submit this form, along with detailed information of the third-party scanning software, for approval.

If your third-party scanning software is not approved, you will be notified by ABC Board staff. If additional information or revisions to your request are necessary, ABC Board staff will notify you of the changes needed and you will be required to resubmit for ABC Board approval.

**\*\*PLEASE NOTE\*\* Any scanning software is strictly a tool to be used in assisting with prevention of e-liquids, electronic nicotine delivery systems, and/or alternative nicotine products from being sold, served, or furnished to a minor. The third-party scanning software shall not release a permit holder from liability for allowing a minor to enter the location or for selling, furnishing, or giving an age-restricted item to individuals under 21 years of age.**
